#### “Dine and Play” PROMOTION DESCRIPTION

Encore Rewards Members will receive a \$15 Slots and Electronic Table Games Free Play if they show a valid promotional paper voucher containing a promotional code (“**Promo Code**”) to select Guest Services location at a Participating Facility during the Promotion Period. For Participating Facilities that have table games, Encore Rewards members will receive a bonus \$15 Table Free Play. To receive a promotional paper voucher, a minimum pre-tax spend of \$10 at a Participating Facility on-site restaurant is required. These vouchers are available while quantities last.

#### DEFINITIONS

Capitalized terms used in this Promotion have the meaning assigned to them in the Encore Rewards Terms and Conditions (<https://www.casinosbc.com/about/encore-terms.html>) unless defined herein

**Free Play** means a \$15 Slots and Electronic Table Games Free Play awarded as 3,000 Encore Rewards Points for redemption on qualified gaming devices, such as slots or electronic table games and \$15 Table Free Play credit awarded as a printed table game voucher for redemption on qualified table games at a BC Casino. The \$15 Table Free Play cannot be exchanged for Slots and Electronic Table Games Free Play

**Encore Rewards Member** means an individual who:

- is a valid Encore Rewards Member during the Promotion Period; and
- is not a BCLC service provider employee.

**Participating Facilities.** Participating Facilities may vary by promotion offer. Participating Facilities by promotional code as listed below:

**PIN** means a personal identification number set up by a Qualified Player to redeem Encore Rewards Points.

**Promotion** means this BCLC Encore Rewards Dine and Play Promotion.

**Promotion Period** means the period from 12:00:00 am PT (midnight) on March 2, 2026 to 11:59:59 pm PT on March 29, 2026.

**Qualified Player** is someone who is 19 years of age or older, physically present in British Columbia, and is an Encore Rewards Member during the Promotion Period but does not include:

- BCLC and Participating Facility employees, as well as family and household members who reside at the same address; or
- Persons who are self-excluded or barred, or who self-exclude or are barred during the Promotion Period from a BC Casino, BC Community Gaming Centre, or PlayNow.com.

#### OFFER CLAIM AND REDEMPTION PROCESS

##### Offer Claiming Process

To receive the Free Play the Qualified Player must:

1. Obtain a promotional paper voucher containing an eligible Promo Code(s), issued by BCLC. To receive a promotional paper voucher, a minimum pre-tax spend of \$10 per individual guest on food and non-alcoholic beverages at a Participating Facility on-site restaurant is required. Alcohol purchases do not count toward the minimum spend. Limit one (1) voucher per Qualified Player during the Promotion Period. The Promo Code is printed directly on the voucher and must be presented at Guest Services during the Promotion Period. Note that the Promo Code expires at the end of the Promotion Period.

- 2. Visit a Guest Services location at a Participating Facility during the Promotion Period, provide their Encore Rewards membership ID, and show the paper voucher with the Promo Code.
  - If a Qualified Player is not a current member of Encore Rewards, they must sign up for an Encore Rewards account either online at [www.casinosbc.com/register.html](http://www.casinosbc.com/register.html) or at a Guest Services location at a Participating Facility, to become a new Encore Rewards Member.
- 3. \$15 Slots and eTable Free Play will be awarded to the Qualified Player’s Encore Rewards account as 3,000 Encore Rewards Points.
- 4. \$15 Table Free Play will be awarded as a free table play voucher.
- 5. Vouchers must be redeemed at Guest Services during the Promotion Period. Vouchers will not be accepted after 11:59:59 PM PT on March 29, 2026.

#### Offer Redemption Process

- 6. To redeem this offer, the Qualified Player must complete the applicable process below:
  - **Slot and eTable Redemption Process** a Qualified Player inserts their Encore Rewards card into any slot or eTable machine at any Participating Facility with their PIN to redeem the 3,000 Points as Free Play.
  - **Table Free Play Redemption Process** a Qualified Player will give the free play voucher to the dealer, and it will be placed on the table as a bet.

#### PROMOTION DETAILS

- 7. Once claimed at any Participating Facility, play credits remain valid for 365 days from the date it is claimed. To redeem the Free Play, Qualified Players must follow the applicable Offer Redemption Process.
- 8. Free Play is automatically applied to the Qualified Player’s Encore Rewards account once the Qualified Player opens a new Encore Rewards Account at a Participating Facility or picks up an Encore Rewards card for the first time.
