**Description of Promotion:**

Encore members can earn entries to win Daily Prizes and the Grand Prize.

**Definitions**

**Daily Prize** is 20,000 Encore Rewards Points awarded four (4) times each Gaming Day at each Participating Facility.

**Daily Prize Draw** means a draw conducted at a Participating Facility to award a Daily Prize.

**Drawn Entrant** means a Qualified Entrant whose name is drawn as a result of the Grand Prize Draw.

**Gaming Day** means the 24 hour period from 7:00 am PT on one day to 6:59 am PT the following day during the Promotion Period.

**Grand Prize** is \$50,000, issued as a cheque, which must be picked up by the Grand Prize Winner at a Participating Facility.

**Grand Prize Draw** means the draw for the Grand Prize that is scheduled to take place at BCLC's Vancouver office on Monday, April 6, 2020, or as soon as practical thereafter.

**How to Enter a Daily Prize Draw**

- Qualified Entrants receive an entry into a Daily Prize draw by earning fifty (50) Encore Rewards points in the two (2) hours before the draw.
- Qualified Entrants may receive a maximum of one (1) entry for each Daily Prize draw, to a maximum of four Daily Prize entries per Gaming Day.
- Qualified Entrants must earn an entry for each Daily Prize draw. Non-winning entries will not be rolled over to the next Daily Prize draw.
- To be eligible to win a Daily Prize, Qualified Entrants must have their Encore Rewards card inserted into a slot machine at the moment a Daily Prize is drawn. Daily Prize draws will be conducted, four (4) times per Gaming Day at each Participating Facility at the following times:

**Daily Prizes**

2. Daily Prizes draws will be conducted at each Participating Facility, and Daily Prizes will be credited to the Winner's Encore account.

**How to Enter the Grand Prize Draw**

1. Qualified Entrants receive an entry into the Grand Prize Draw each time they earn a Daily Prize Entry.
2. A Qualified Entrant can receive a maximum of four (4) entries per Gaming Day.

**Grand Prize**

1. There is one (1) Grand Prize available to be won in this promotion.
2. The Grand Prize Draw will occur on Monday, March 6, 2020 or as soon as possible thereafter, from all virtual entries received during the Promotion Period.
3. A BCLC representative will attempt to contact the Drawn Entrant for the Grand Prize by telephone and/or by email using the contact information provided on his/her Encore Rewards member profile. If the Drawn Entrant cannot be contacted within seven (7) business days from BCLC's first attempt to contact them then the Drawn Entrant will be disqualified and another Drawn Entrant will be selected.
4. Drawn Entrant will be required, at their own expense, to visit a Participating Facility to claim their prize within 30 days of their contact with BCLC. If the Drawn Entrant is not able to visit a Participating Facility to claim their prize within the 30 days, then the prize will be forfeited and another Drawn Entrant will be selected as the Grand Prize winner.
5. Drawn Entrant will be required to present valid photo identification, and must complete a Winner's Authorization Form in the presence of two (2) registered gaming employees, before the Grand Prize will be awarded. If a Drawn Entrant does not comply with the above
