**Lunar New Year Product Campaign (2026)**

**1) Promotion:** Lunar New Year – Product (2026) (the “Promotion”).

**2) Promotion Period:** 7:00 am PST January 26, 2026, to 6:59 am PST February 22, 2026.

**3) Gaming Day:** the 24-hour period from 7:00 am PST on one day to 6:59 am PST the following day.

  - b. not be a BCLC service provider employee.

- 7) **How to Enter:** To receive a red envelope, a Qualified Entrant must present their Encore Rewards card at Guest Services at a Participating Facility during the Promotion Period.
- 8) **Number of Entries:** One (1) red envelope per Qualified Entrant per Gaming Day across all Participating Facilities, regardless of number of visits or locations visited.  
Entries must be received by BCLC before the end of the Promotion Period.
