

ENCORE REWARDS EXPRESS ENTRY PILOT OFFER DESCRIPTION

The first 200 eligible Encore Rewards members who participate in the Express Entry Pilot and complete all the required steps will receive \$50 in Free Play awarded as 10,000 Encore Rewards Points (the "**Prize**").

DEFINITIONS

Capitalized terms used in this Promotion have the meaning assigned thereto in the <u>Encore Rewards Terms</u> and Conditions unless defined herein.

"Encore Rewards Points" or "Points" means the points rewarded to individual members of the Program by BCLC.

"Encore Rewards Program" or "Program" means the membership and tiered bonus rewards program established by BCLC for players residing in British Columbia ("BC").

"Free Play" or **"Prize"** means a \$50 credit awarded as 10,000 Encore Rewards Points for redemption on slots or electronic table games (**"eTable"**), or at Guest Services for table games. Points redeemed for table games must be redeemed as a free play voucher.

"Promotion Period" means the period from 12:00:00 AM PT on August 14, 2025, to 11:59:59 PM PT on August 31, 2025.

"Participating Facility" means Grand Villa Casino.

"PIN" means a personal identification number set up by a Qualified Player to redeem Encore Rewards Points.

"Qualified Player" is an individual who is 19 years of age or older, that:

- a. is a valid Encore Rewards Member;
- b. has been invited to participate in the Express Entry Pilot via email communication; and
- c. is not:
 - a BCLC or Participating Facility employee or contractor, or a family member, or a household member of such employees or contractors who reside at the same address; or
 - ii. a participant in BCLC's Game Break Program or barred from a Participating Facility.

HOW TO PARTICIPATE IN THIS PROMOTION

- 1. To qualify for the Prize, Qualified Players must complete the following steps within the Promotion Period:
 - a) create an Encore Rewards online account;
 - b) download the Encore Rewards Pilot App via the iOS or Android link provided on the <u>Encore Rewards Express Entry landing page</u>;
 - c) log into the Pilot App using your Encore Rewards online account credentials and complete the in-app ID verification process;
 - d) visit Grand Villa Casino and scan the Express Entry QR Code at Entry using the Encore Rewards Pilot App;
 - e) complete the survey via the link that will be sent through the Pilot App after their casino visit.





- 2. Only the first 200 participants to complete all these steps will receive the Prize.
- 3. The Prize will be awarded to the successful participants within 15 business days of completing the survey.

OFFER REDEMPTION PROCESS

- 4. The Prize awarded must be redeemed by completing one of the following Encore Rewards Points redemption processes:
 - a. **eTable Redemption Process**: Qualified Player inserts their Encore Rewards Card or enters the phone number and PIN associated with their Encore Rewards account into any eTable machine at the Participating Facility with their PIN to redeem the Encore Rewards Points as Free Play;
 - a. **Slot Free Play Redemption Process**: Qualified Player inserts their Encore Rewards Card or enters the phone number and PIN associated with their Encore Rewards account into any slot machine at the Participating Facility with their PIN to redeem the Encore Rewards Points as Free Play; or
 - b. **Table Free Play Redemption Process**: Qualified Player notifies Guest Services that they would like to redeem the Encore Rewards Points at table games and then the Qualified Player receives a voucher for Table Free Play. The Qualified Player will give this voucher to the Dealer, and it will be placed on the table as a bet.
- 5. The winner must redeem the Free Play at any BC Casino and Community Gaming Centre within 365 days from the date it is awarded. An expired Free Play will not be reactivated.

GENERAL CONDITIONS

- BCLC reserves the right to substitute a Prize or portion thereof with one of equal or greater value. Prizes must be accepted as awarded.
- 7. BCLC reserves the right to disqualify entrants and entries that do not comply with these conditions.
- BCLC is not responsible for lost, misdirected, misplaced, incorrect, illegible or damaged entries or entries submitted after the promotion deadline.
- 9. BCLC makes no representations or warranties whatsoever, expressed or implied, oral or written in respect of a Prize.

Entrants hereby attorn to the exclusive jurisdiction of the courts of the Province of British Columbia and all courts





competent to hear appeals therefrom to settle any dispute or claim that arises out of or in connection with these conditions or the contest (including without limitation non-contractual disputes or claims).

If any provision herein is determined to be illegal or unenforceable by a court of competent jurisdiction, that provision will be severed from these conditions and the remaining provisions will remain in full force and effect if the economic or legal substance of the conditions is not affected in a manner materially adverse to either party.
- BCLC is not liable for lost, stolen, damaged, unregistered, or improperly inserted Encore Rewards Cards, or any error or miscalculation.
- 16. Encore Rewards Cards must not be transferred. If an Encore Rewards member distributes their Encore Rewards Card to other players, they will not be eligible to participate in this Promotion and may have their Encore Rewards membership revoked. A person who uses another person's Encore Rewards Card is also disqualified from participation in this Promotion and is not eligible to receive a Free Play.
- 17. BCLC reserves the right not to award any Encore Rewards Points if the integrity of all or a part of the Promotion is compromised. Such a compromise shall include, but is not limited to, computer error, slot machine malfunction, electronic table malfunction, fraud, deception, misrepresentation, or misuse.
- 18. BCLC may, at its sole discretion, and without liability to any individual, participant, or Qualified Player, alter, amend, suspend, or cancel this Promotion at any time.
- 19. BCLC reserves the right to change or restrict Encore Rewards earnings or other awards on specific slot machines, table games, or eTable games.
- BCLC shall not be liable to any person for loss or damage to person or property resulting from or connected with acts or omissions of BCLC, any Participating Facility, or a service provider.
- 21. Each Qualified Player is responsible for ensuring that their Encore Rewards member profile is accurate, up-to-date, and has current and correct contact information, including a telephone number and email address at which they can be contacted.
- 22. Each Qualified Player shall indemnify and hold harmless BCLC and its directors, officers, employees, representatives, contractors, agents, and affiliates (collectively, the "Released Parties") from and against any and all actions, claims, or demands by the qualified player (including costs incurred by any of the released parties in defending such actions, claims, or demands) brought against the released parties in relation to this promotion or prize.
- 23. Encore Rewards Points earned in this Promotion must be accepted as awarded, cannot be transferred, cannot be exchanged for cash, and must be redeemed in accordance with the Offer Redemption Process and Encore Rewards Membership Terms and Conditions.
- 24. A Qualified Player must notify BCLC of any omissions or discrepancies to their Encore Rewards Points balance within 60 days of earning, receiving, or using the applicable Points. BCLC may require a Qualified Player to provide documentation in support of any requested correction.
- 25. BCLC will not be liable for and may adjust or cancel a Qualified Player's Encore Rewards Points balance where Encore Rewards Points have accrued due to malfunction, operator error, misrepresentation, fraud, misuse, or any other reason BCLC deems valid.
- 26. In the instance of system error of Encore Rewards Points transactions, adjustments will not be made to player accounts where the difference (in favour of or against the Qualified Player) is less than one (1) dollar within a single Gaming Day.
- 27. All stated dollar amounts are in Canadian funds.





- 28. All BCLC decisions are final and binding. BCLC reserves the right to disqualify any individual or Qualified Player that does not comply with the Promotion terms and conditions.
