

Promotion-Specific Conditions

Encore Rewards Insider Giveaway

1) **Promotion:** Encore Rewards Insider Giveaway (the “**Promotion**”)

This Promotion is governed by these terms and conditions (the “**Conditions**”) as well as BCLC’s General Terms and Conditions for Promotions (the “**General Conditions**”). Where the Conditions and the General Conditions conflict, these Conditions will prevail.

2) **Promotion Period:** The Promotion begins at 1:00:00 PM PST on April 23, 2026 and ends at 11:59:59 PM PST on April 26, 2026.

3) **Prize:** Five (5) prizes (each a “**Prize**”) are available to be won.

Each Prize consists of:

- i. one (1) gift card to any MATCH Eatery & Public House location within British Columbia with a retail value of one hundred dollars (\$100); and
- ii. twenty thousand (20,000) Encore Rewards Points, with an approximate value of one hundred dollars (\$100), redeemable:
 - o on slot machines or electronic table games;
 - o at Guest Services for table games (as a bonus play voucher); or
 - o on PlayNow.com.

The approximate retail value of each Prize is two hundred dollars (\$200).

There are five (5) Prizes available to be won in this Promotion. Winners may receive a maximum of one (1) Prize in this Promotion.

4) **Qualified Entrant:** in addition to the requirements for a Qualified Entrant in the General Conditions, for this promotion the entrant must:

- a) be a valid Encore Rewards member;
- b) have opted in to receive Encore Rewards marketing communications;
- c) have “Email” selected as a communication channel preference and has a valid email address; and
- d) not be an employee or contractor of BCLC or a Participating Facility, or a family or household member (residing at the same address) of such employee or contractor.

5) **How to Enter:** During the Promotion Period, a Qualified Entrant may receive one (1) entry into the Promotion by:

- a) receiving the Encore Rewards April 23, 2026 eNewsletter (the "Communication"); and
- b) clicking on the Promotion message contained within the Communication.

Qualified Entrants who do not receive the Communication or who do not correctly click on the Promotion message within the Communication are not eligible to receive an entry.

6) **Number of Entries:** A Qualified Entrant may receive a maximum of one (1) entry in this Promotion (each an "Entry").

Entries must be received by BCLC before the end of the Promotion Period.

7) **Draw(s):** A random draw to select five (5) entries will be conducted on Tuesday, April 28, 2026, or as soon as practicable thereafter, by an authorized BCLC representative in the presence of one (1) witness who is at least nineteen (19) years of age.

8) **Odds:** Odds of winning depend on the number of Entries received during the Promotion Period.

9) **No Purchase Necessary:** No purchase is necessary to enter this Promotion.

10) **Conditions of Prize:** The Winner is solely responsible for:

- a) any costs or expenses not expressly included in the Prize, including additional experiences, entertainment charges, taxes, fees, gratuities, and personal expenses; and
- b) any expenses incurred while using the Prize, including medical expenses, travel costs, or lost or stolen items.

BCLC reserves the right to substitute a Prize, or any portion thereof, with one of equal or greater value.

11) **Time to Claim Prize:** To be declared a Winner, a Drawn Entrant must, within seven (7) days of BCLC's first attempt to contact the Drawn Entrant:

- a) respond to BCLC;
- b) provide government-issued photo identification and proof of eligibility, as required;
- c) correctly answer a time-limited mathematical skill-testing question without assistance; and

d) execute any releases, indemnities, or declarations required by BCLC.

Failure to meet these requirements may result in disqualification and selection of an alternate entrant.
