

Promotion-Specific Conditions

Encore Rewards PNE Fair Free Entry Day Offer

1) **Promotion:** Encore Rewards PNE Fair Free Entry Day Offer

This Promotion is governed by these terms and conditions (the “**Conditions**”) as well as BCLC’s [General Terms and Conditions for Promotions](#) (the “**General Conditions**”). Where these Conditions and the General Conditions conflict, these Conditions will prevail.

2) **Promotion Period:** From 12:00:00 AM PT on August 25, 2026 to 11:59:59 PM PT on September 5, 2026, or while quantities last, whichever occurs first. Free PNE Fair admission is valid only on September 6, 2026.

3) **Offer:**

- a) Eligible Encore Rewards members may receive one (1) unique PNE Fair admission code that can be redeemed online through the PNE ticketing website for one (1) complimentary general admission ticket to the PNE Fair on September 6, 2026.
- b) The Offer is available while quantities last. Once all available admission codes have been claimed, no additional requests can be fulfilled.
- c) Each eligible Encore Rewards member may receive a maximum of one (1) admission code under this Promotion.
- d) The admission code has no cash value, is not a prize, is not transferable, and cannot be exchanged for cash, Bonus Play, another offer, or any other substitute.

4) **Where to Claim:** This Promotion is available online through CasinosBC.com. PNE admission codes must be redeemed through the PNE online ticketing system and will not be distributed at the PNE gate.

5) **Qualified Member:** In addition to the requirements for eligibility in the General Conditions, to qualify for this Promotion a member must:

- a) be a valid Encore Rewards member;
- b) have an active Encore Rewards account at the time the request is submitted;
- c) have a valid email address associated with their Encore Rewards account so the admission code can be delivered;
- d) submit a request during the Promotion Period using the form provided on CasinosBC.com; and

- e) not be enrolled in Game Break or otherwise ineligible under BCLC's rules, policies, or the General Conditions.
- f) Pending, inactive, closed, duplicate, or otherwise ineligible Encore Rewards accounts do not qualify.

6) How to Claim the Offer:

- a) To request a PNE Fair admission code, a Qualified Member must complete the request form on CasinosBC.com during the Promotion Period by providing the required information, which may include their Encore Rewards account number, first name, and last name.
- b) BCLC will verify the Encore Rewards account information submitted through the form. If the member is eligible and admission codes remain available, a unique PNE Fair admission code will be sent to the email address associated with the member's Encore Rewards account. Codes are typically delivered within approximately one (1) hour of submitting the form, but delivery times may vary.
- c) The member must then redeem the unique admission code through the PNE online ticketing system to claim one (1) complimentary general admission ticket for September 6, 2026. The member is responsible for completing the ticket registration process on the PNE website and bringing their ticket to the PNE Fair gate on September 6, 2026.
- d) Duplicate requests, incomplete submissions, requests using an invalid account number, or requests associated with an ineligible account may be declined.

7) Offer Limit: There is a limit of one (1) unique admission code per eligible Encore Rewards member.

8) Availability: The Offer is available while quantities last. If all available PNE Fair admission codes have been claimed, the Promotion may end before 11:59:59 PM PT on September 5, 2026, and additional requests cannot be fulfilled.

9) Conditions of Offer: In addition to the General Conditions:

- a) PNE Fair admission codes are valid only for complimentary general admission to the PNE Fair on September 6, 2026;
- b) admission codes must be redeemed online through the PNE ticketing system and will not be distributed at the gate;
- c) admission codes may be subject to additional terms, conditions, and redemption instructions set by the PNE or its ticketing provider;
- d) BCLC is not responsible for any failure, delay, or issue related to the PNE ticketing website, ticket registration process, ticket delivery, or gate admission

process;

- e) BCLC is not responsible for incorrect, outdated, or missing email addresses associated with an Encore Rewards account;
- f) BCLC is not responsible for lost, deleted, delayed, misdirected, undeliverable, or inaccessible emails containing admission codes; and
- g) the member is responsible for ensuring they redeem their code and obtain their PNE ticket before attending the PNE Fair.

10)Additional Conditions: In addition to the General Conditions:

- a) BCLC is not liable for lost, stolen, damaged, or unregistered Encore Rewards cards;
- b) if an Encore Rewards member distributes their Encore Rewards card or account information to another person, BCLC may deem the member ineligible for this Promotion and may revoke the Offer;
- c) BCLC reserves the right to verify eligibility and deny or cancel any request that appears to be fraudulent, incomplete, duplicated, automated, or otherwise inconsistent with these Conditions;
- d) BCLC may modify, suspend, or cancel this Promotion if technical issues, fraud, operational issues, PNE ticketing issues, or other circumstances affect the administration, integrity, availability, or security of the Promotion; and
- e) BCLC's decisions regarding eligibility, code availability, fulfillment, and administration of this Promotion are final.

11)No Contest or Prize Draw: This Promotion is not a contest, sweepstakes, lottery, or prize draw. There is no random draw, no odds of winning, and no skill-testing question. Eligible members who successfully complete the claim process during the Promotion Period will receive one (1) admission code while quantities last.
